For more than twenty years, Laurent Levy has created, organised and managed high-growth activities within major digital services companies (DSC), including Steria, Transiciel, Capgemini and Atos Origin, as Director for France and as a member of the management committee. He was the founder and manager of the European Security Centre for the Capgemini Group (ESEC) for 5 years, before extending his scope of activity to the creation and management of transversal IT-Consulting and transformation activities for large organisations. In 2009, he founded INOP'S with a simple idea: to give key accounts direct access to the best digital experts.

Laurent Levy's first task as Managing Director of Freelance.com will be to implement the industrial and commercial synergies of the two newly merged entities.
