Completion of the contribution in kind of 100% of the capital of Coworkees to Freelance.com

At the extraordinary general meeting of 5 March 2021, the shareholders of Freelance.com (**Euronext Growth Paris - FR0004187367 - ALFRE**) voted in favour of a contribution in kind of all the shares of Coworkees to Freelance.Com and the resulting capital increase. As a reminder, Freelance.com had communicated on 22 January 2021 on this project of contribution in kind, in line with its project to strengthen its community of external talents with new specialist profiles and thus to respond ever more effectively to the needs of companies

Consequently, in order to remunerate this contribution, Freelance.com announces that it has increased its capital by issuing 494,986 shares at a price of €4.83 per share to Coworkees shareholders. Julie Huguet remains the Managing Director of Coworkees.

Coworkees is an innovative platform that makes it easy to source a talent or team from a community of 25,000 freelancers specialising in marketing and communication in France and Switzerland. The company employs a team of 10 people based in Annecy and assists more than 1,000 clients with their projects (advertising campaigns, website creation and redesign, content creation, etc.).

As of today, the share capital of Freelance.com is now made up of 36,918,685 shares.
