Created in 2009 as part of Freelance.com, the Provigis platform secures business relationships between companies by acting as a third-party collection agency. This subsidiary, whose activity is complementary to but not strategic for Freelance.com, was managed independently of the Group's core business. It represents less than 3% of total consolidated sales and EBITDA.
